BOAT LAUNCH USE AGREEMENT

The launch ramp located at 6th Ave. is on PRIVATE PROPERTY, controlled by the Deep Lake Improvement Association (DLIA). This property is clearly labeled NO TRESPASSING and is **for use of a dues-paying member and the accompanied out-of-neighborhood guest only.** Use of the launch ramp requires the payment of a separate fee which authorizes a **non-transferable**

right to launch for one season. Any unauthorized use of the property will be considered trespass and may be subject to prosecution. The ramp is for private use only and any intended commercial use must first be presented to the Board for approval.

Parked cars, boats or trailers are no longer allowed along the access road. Do not attempt to use access road when the launch is already in use. Please wait your turn at the top of the hill and allow room for others to get by.

By paying the ramp fee & accepting a gate key, I AGREE TO ABIDE BY THE FOLLOWING RULES AND REGULATIONS:

- 1. I AGREE TO ABIDE BY THE LAKE USE GUIDELINES AS SET OUT BY THE ASSOCIATION, AND THE ILLINOIS BOAT REGISTRATION AND SAFETY ACT (625 ILCS 45).
- 2. I agree that at the time of the launch, I, or members of my immediate household, will be in control of the gate key. Keys may not be loaned to anyone (not even neighbors).
- 3. I agree that only one out-of-neighborhood guest motorized watercraft can be launched per day and remain on the lake for a maximum of four (4) days. To launch multiple out-of-neighborhood guest watercrafts per day or for a guest watercraft to remain on the lake for an extended period needs prior approval from the DLIA Board.
- 4. I agree that any boat launched by me, or my guest, will be properly licensed by the State of Illinois and will have the safety equipment and inspections required by the U.S. Coast Guard.
- 5. I agree to accept the liability for any damage that I, or my guest, may cause or incur. Use of this property does not convey liability to the Association either directly or indirectly due to my actions. (All boaters would be wise to purchase liability insurance.)
- 6. I agree that I will not anchor overnight on ANY private property without the permission of the property owner. This includes private underwater property and Association property.
- 7. I AGREE NOT TO POWER LOAD AND/OR USE EXCESSIVE ACCELERATION WHEN LAUNCHING OR REMOVING MY BOAT.
